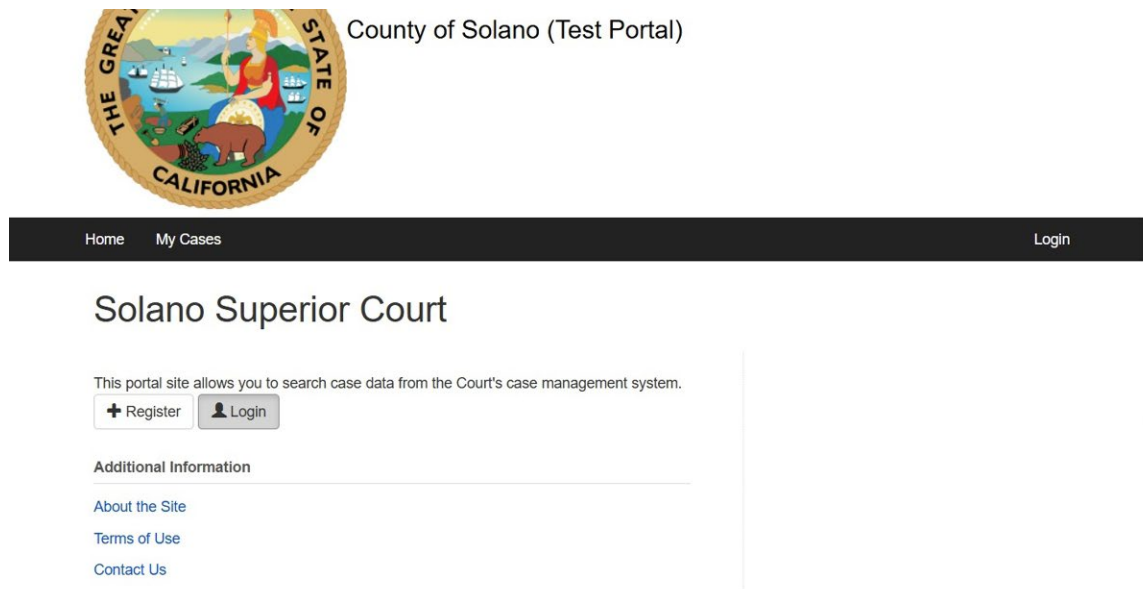




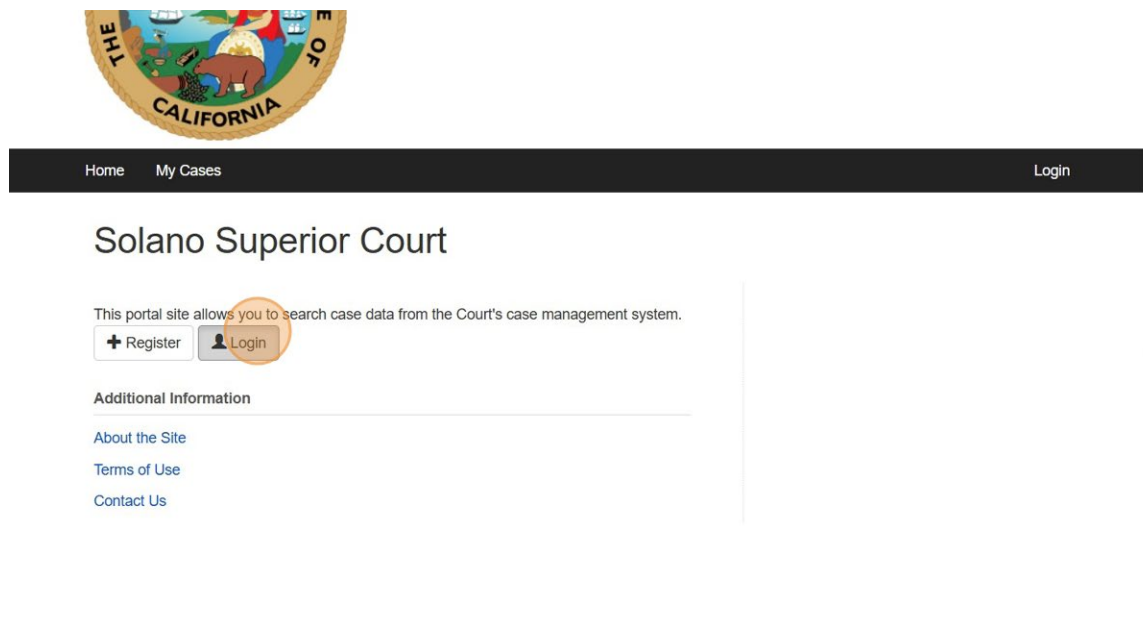

1. Navigate to <https://portal.solano.courts.ca.gov:8443/>
